In collaboration with State Bank of Pakistan (SBP), Controller General of Accounts (CGA) Office has taken initiative of Micro Payment Gateway (MPG). MPG is a real time integration with SAP for online transfer of salaries and pension from Accounting Offices i.e. AGPR and its sub offices. It will facilitate all employees in swift transfer of salaries & pension by discontinuing the traditional instruments that is Cheques to designated commercial banks, hardcopy of bank advices of Payroll/Pension Roll and DL etc.

International Bank account Number (IBAN) is a pre-requisite for MPG implementation. You are, therefore, requested to direct all employees of AGPR to **provide their IBANs till 15 October, 2020**. As per applicable procedure, Computer Change Statements on FO2 form duly verified by DDO and concerned Pre-audit sections i.e GA-4 and TA-3 may please be submitted before deadline/cut-off date.


