OFFICE MEMORANDUM

Subject: - **BIOMETRIC VERIFICATION SERVICE**

The undersigned is directed to refer to Finance Division (Budget Wing)'s Notification No.F.2 (5) PFMR-II/2020, dated 28th January, 2021 according to which a Direct Credit System (DCS) pensioner is required to undergo biometric verification on National Database and Registration Authority (NADRA) system through any branch of a bank every year in the months of March and October. The same was held in abeyance vide Finance Division O.M. of even number dated 6th May, 2021, due to COVID-19.

2. Given that normal working has been restored, therefore, it has been decided to operationalize the Biometric Verification Service for Federal Government Pensioners with immediate effect who were issued pension from AGPR Islamabad (for military pensioner, and those who were issued pension from AGPR sub-offices and District Account Offices will be communicated separately).

Pension Payment through Direct Credit System (DCS)

Please refer to BC&CPD Circular Letter No. 01 dated February 01, 2021 and File Letter No. BC&CPD/O&SSD/BVS/5873 dated May 27, 2021 on the subject.
