

Tender Notice

- i. Office of the Accountant General Pakistan Revenues invites sealed tenders from reputable experienced firms registered with PPRA on EPADS to provide Janitorial Services including provision of cleaning material and supplies at office of the AGPR located at G-8/4, Islamabad, **through EPADS only**, for a period of **one year**, further extendable up to **two years** with mutual consent on satisfactory performance of contractor.
- ii. The firms must be registered with Employee Old Age Benefit institution (EOBI) for EOBI deductions/payments under EOBI act.
- iii. The firms must be registered Federal Board of Revenue and on Active Taxpayers List of FBR and fulfill the other eligibility criteria/ terms and conditions as per tender document.
- iv. The firms should quote their rates while ensuring compliance with the Federal Government's minimum wage requirements. Any increase or decrease in rates imposed by the Government or ICT administration during the term of this agreement shall be accommodated by the AGPR.
- v. Interested and eligible firms may submit their bids using single stage two envelop procedure under the PPRA Rules, 2004.
- vi. The bids must reached/uploaded latest by **26 March 2025 at 11:00 AM**, which shall be opened through PPRA EPADS on the same day at 11:30 AM in presence of representative of the bidders who may wish to be present.
- vii. Financial Bid / Financial Proposal must be accompanied by the earnest money i.e. Rs 300,000/- (Rupees: Three Hundred Thousand only.)
