



The vehicles are parked in the premises of AGPR Islamabad and can be inspected during working days from **10: 00 A.M to 01:00 P.M on March 19 and March 20, 2025.**

Terms of Auction: -

- The bidders must bring their original CNIC and provide complete address / telephone numbers and attested copy of CNIC on the day of Auction.
- Successful bidder must deposit earnest money i.e. 10% of the bid **in cash** on the spot and remaining amount must be deposited within **05 days** of auction. In cases of default, earnest money shall be forfeited.
- The payment of outstanding token tax / dues will be the responsibility of successful bidder.
- The bidder to participate in the bidding process shall deposit a refundable bid security of Rs.30,000/- (Rupees: Thirty Thousand Only) for the vehicles in shape of demand draft in the name of **Branch Officer Admin-II, AGPR, Islamabad.**
- The transfer of ownership documents would be the responsibility of the successful bidder.
- Documents of the vehicle (s) will be delivered after complete payment only.
- Withholding tax on the bid amount shall be charged, as per prevailing rules
- Successful bidder shall check the chassis / engine number and documents etc, before taking over the vehicle; this office will not be responsible for any complaint later on.
- Possession of vehicles will be given to the successful bidder, after transfer of vehicle in his name from the ETO concerned.
- The Auction Committee / Competent Authority reserve the right to accept or reject any or all bids in accordance with rule 33 of the PPRA Rules, 2004.
